5. Update re: NWT Archives Council's application for education support. Ian reported on the current status of the Council's current NADP application for education support. He noted that the NADP review committee had a greater number of questions in late March regarding this year's application (ca. \$6K) than in previous years. Part of the issue is in requesting funding when education opportunities are not announced until months after the NADP application deadline. The NADP program is in its final year and may be under increased scrutiny. Ian will keep council members informed of the application status. Question from Ingrid: This education support is available to all members? Answer from Ian: Yes, the education support is available to all members, and usually covers part of the cost of educational opportunities, whether they are down south or in the NWT.

Comment from Peter Harding: Library and Archives Canada has been an institutional member in the past, but federal cutbacks have discontinued that practice.
